Dear Sir/Madam:

Enclosed are copies of notices we have given to eleven companies that provide telephone and Internet services to Minnesota customers. Those notices were issued under the authority granted our agency (state law enforcement) in 18 USC 1084(d). In our notice we have requested these companies prohibit their Minnesota customers from receiving gambling information. This information is being made available through so called online casino operations. Online gambling is illegal in our jurisdiction. We have started this effort by providing, for their convenience, a list of about 200 online entities. If this process proves successful we will continue with more sites and more providers.

Please understand we are only asking that persons in Minnesota not be allowed access to the identified sites or phone numbers. The online gambling operations are free to offer their services wherever they may lawfully.

Since it is my understanding these companies are subject to your regulatory authority, I wanted to make you aware of the notices. By doing so, I hope you will be able to help us ensure that those we have sent notices are mindful of the need to comply.

If you should need anything more from our agency, or wish to discuss this action please let me know.

TITLE 18--CRIMES AND CRIMINAL PROCEDURE

PART I--CRIMES

CHAPTER 50--GAMBLING

Sec. 1084. Transmission of wagering information; penalties

(a) Whoever being engaged in the business of betting or wagering knowingly uses a wire communication facility for the transmission in interstate or foreign commerce of bets or wagers or information assisting in the placing of bets or wagers on any sporting event or contest, or for the transmission of a wire communication which entitles the recipient to receive money or credit as a result of bets or wagers, or for information assisting in the placing of bets or wagers, shall be fined under this title or imprisoned not more than two years, or both.

(b) Nothing in this section shall be construed to prevent the transmission in interstate or foreign commerce of information for use in news reporting of sporting events or contests, or for the transmission of information assisting in the placing of bets or wagers on a sporting event or contest from a State or foreign country where betting on that sporting event or contest is legal into a State or foreign country in which such betting is legal.

(c) Nothing contained in this section shall create immunity from criminal prosecution under any laws of any State.

(d) When any common carrier, subject to the jurisdiction of the Federal Communications Commission, is notified in writing by a Federal, State, or local law enforcement agency, acting within its jurisdiction, that any facility furnished by it is being used or will be used for the purpose of transmitting or receiving gambling information in interstate or foreign commerce in violation of Federal, State or local law, it shall discontinue or refuse, the leasing, furnishing, or maintaining of such facility, after reasonable notice to the subscriber, but no damages, penalty or forfeiture, civil or criminal, shall be found against any common carrier for any act done in compliance with any notice received from a law enforcement agency. Nothing in this section shall be deemed to prejudice the right of any person affected thereby to secure an appropriate determination, as otherwise provided by law, in a Federal court or in a State or local tribunal or agency, that such facility should not be discontinued or removed, or should be restored. ("emphasis added")

(e) As used in this section, the term "State" means a State of the United States, the District of Columbia, the Commonwealth of Puerto Rico, or a commonwealth, territory or possession of the United States.
